#### Manager's Report – Sept 2022

#### Aug 18 – Cargill Soil field day – SROC

Attended and staffed an information booth with Faribault SWCD. Attendance around 60 with a few local producers I recognized. Presentations on carbon markets, SROC research, soil pit, rainfall simulator, and farmer panel. Event was well planned and provided good information. SROC staff did a great job on the tour.

#### Aug 24 - GBERBA tech

Big news was that GBERBA's CWF application for soil health was selected for funding by BWSR. Application was for \$312,000 and was ranked third. Grant had to have a drinking water focus so Drinking Water Supply Management Areas were targeted. More info to be developed in terms of policy, eligibility, and payment rates. Watonwan grants underwent some workplan budget shifts and some minor policy shifts.

#### **LS 1W1P**

Moving toward draft plan and final edits of implementation table. Anticipated draft plan available in October. Policy committee intends on making a decision on plan administration in Sept. Policy meetings have had good attendance.

#### Cannon 1W1P

Staff discussed ongoing efforts of the group including PTMAPP updates, septic inventory, and lake monitoring. Waseca staff will be conducting an inventory of Toner's Lake in October for part of this effort. Staff are putting together a draft workplan for the next round of funding. Workplan currently includes \$300,000 for a water storage project in Le Sueur County. Two of the three soil health events were completed in the last month. Turnout and quality of presentations were good.
