Manager's Report – March 2023

Hwy 14 Soil Health Workshop

We had good attendance (even after lunch) with about 110 in the audience. Presentations were well received and we had a good custom operator's panel. We were lucky to have decent weather, but the other two stops rescheduled their events until March due to the blizzard.

<u>LS 1W1P</u>

Working through legal agreements of joint powers agreement, by laws, fiscal agreement, and sub-agreements between fiscal and other parties. Documents are taking substantial time to review and edit. Public hearing and final plan submission are next major steps.

Legislative Day - March 7 & 8th - St. Paul

Good presentation by MASWCD and Goff public on legislative session and status of the SWCD Aid bill. 100-150 supervisors and staff from around the state in attendance. SWCD aid is looking promising this year with inclusion in the preliminary Governor's budget, authored bills in the House and Senate, and BWSR support. \$22 million annually would provide SWCDs financial stability and additional flexibility to do local priority projects. I had good meetings with Sen Jasinski, Sen Dornink, Rep Petersburg, and Rep Daniels. Rep Bennett was sick unfortunately and I will try to meet with her later.
